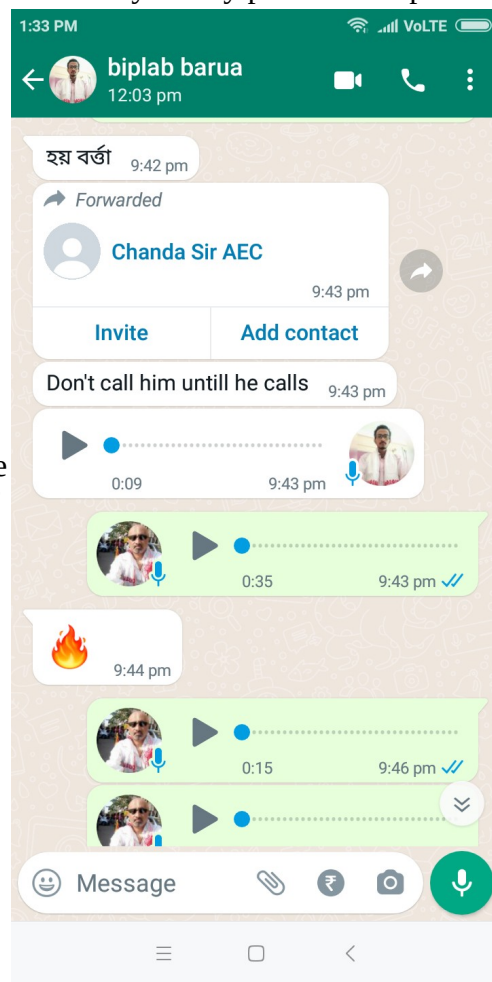
The Meaning of the one liner is :

Here was the conversation:

me: Ganguly, do you drive a mercedes benz ? Do you drive a mercedes benz ?

She: Who are you ?

Me: My name is Abhi Barthakur

She: <silent>

Me: Are you taking my name, address and phone number to file a court case against me ?

She: <silent>

Me: Amrita, Amrita ...

She: <hanged up >

There after, Mr. Barua wrote this FIR under pressure from a group of professors and Mrs. Gagnuly theretening Mr. Barua that he will NOT be able to get any clearence for another 8 years if he does not file this FIR. The audio of Mr. Barua's phone call is available on my server at the following

where he CLEARLY states that he had to do it in order to appear exam.

I never threatned any staff or faculty of Mr. Barua's institution neither legally nor bodily. The claim on the FIR is fake, false and phony.
